- All Fees Quoted are the Attorney's Fees, there is usually Costs/Fines involved which are in addition to the attorney's fees.

Those receiving regular "paychecks" & are paying back 100% of their debt. Only Costs to be paid in advance, the Base Fee will be paid through the "Plan".	\$4,000	\$350	\$4,350
All others (Self-Employed, less than 100% pay back, "Rush" filings, and so forth). \$1,000 in advance before filing, plus Costs, the balance paid through the "Plan".	\$5,000	\$350	\$5,350

\*Chapter 13 Fees are normally paid through the "Plan", meaning Mr. Casey receives a portion of his fee from every Plan Payment you make until those fee are paid in full. Costs must be paid in advance.

Follow-Up Fee  Per Appearance

For the "Plea Only" you get 2 appearances at court by Mr. Casey.

- The First appearance Mr. Casey will attempt to negotiate the Plea Bargain ("Deal").
- Then you are required to get Mr. Casey the necessary documents (Fine Money, properly executed Plea in Absentia, Insurance Letter and so forth) before the next court appearance.
- The second court appearance is to actually Plea you out with the necessary Documents.
- If you do not timely get the necessary documents to Mr. Casey then you will be charged the Follow-Up Fee. If you do not comply and do not pay the Follow-Up Fee, then your case will be set for trial and you Must appear on that court or you may be arrested.

<b>Footnotes</b>
